33/16 Apologies for Absence – Rachel Hibbert, Joan Evans

35/16 Public Forum

Cricket Ground - The clerk referred to a complaint from a resident of Park Avenue relating to an incident when a cricket ball was hit into her garden. One option proposed by the cricket Club was to erect nets that could lowered when there was no match. **It was agreed to conduct a survey of other residents to find out their views.** Councillor Hole offered to speak to the residents and report back.

Removal of Bench - There had also been a query raised by a resident about the removal of the bench outside the new development on Rowthorne Lane. It was agreed that he be informed that the Council had given permission for the bench to be relocated.

Request for Bus Shelter – A resident had asked the Council to consider erecting a new bus shelter for the bus stop opposite the Back Lane. This request was considered but because of information gained on the cost of moving utilities to put a ramp in the same area it was likely that the cost would be prohibitive.

Police – There was no report. John Jepson referred to an ongoing problem with heavy lorries speeding through the village, particularly in the evening/early mornings. It was agreed that the issue be reported to the Community Safety Team.

Emergency Lighting System – Quotes were being obtained for the necessary work. It had been advised that the fittings needed to be replaced and this would be a similar price to that quoted by Firecall. It was agreed that the Council needed to proceed as a matter of urgency once all the quotes were available.

Arising from the discussion with Vault Securities they had offered to remove the previous stacks housing the CCTV cameras at no cost if they could use them at the Football Ground. **This was agreed.**

Grant to PCC – It was proposed that the Council pay £1000 towards the maintenance of the churchyard. **This was agreed.**
