#### 111/18 Public Forum

**Dog Fouling** – Mr and Mrs Creasey requested action on controlling dog fouling in the village. Tony Trafford explained that there was a dog warden employed by Bolsover District Council who was empowered to take action against those responsible for dog fouling. However evidence is required. Mrs Creasey had already reported two individuals and provided information. She suggested that more notices were displayed on lampposts to point out the consequences. This was noted.

**Parking on Grass Verges –** Mr and Mrs Creasey also asked for action to protect the grass verges damaged by parked cars. Tony Trafford informed them that there was a plan with Bolsover District Council to establish some new parking spaces around the village but this was subject to obtaining funding. It was confirmed that there were no regulations to govern parking on pavements.

# A number of matters were referred from the meeting of the Finance Committee:

**Budget 2019/18 –** Tony Trafford reported that there had been an initial discussion on the budget for 2019/20. A draft budget had been produced and it

had been agreed that further discussion will take place at a meeting of the Finance Committee on 6<sup>th</sup> December.

**Remembrance Sunday** – Rachel Hibbert reported that she had been approached by residents to ask why there had been no poppies on lamp posts to commemorate the centenary of the ending of the First World War. The clerk had also received two queries from local residents.

Members regretted that this matter had not been brought to their attention before the event and it was confirmed that the Council had not been approached about the availability of merchandise such as the poppies for the lamp posts. A donation to the British Royal Legion and a poppy wreath had been laid on Remembrance Sunday. It was agreed to review the Council's contribution for Remembrance Sunday in 2019.

**Grounds Maintenance on Park Avenue, Glapwell** – Steve Brunt from Bolsover District Council had queried the level of maintenance proposed by the Council on Park Avenue. It was confirmed that the work by volunteers residents offered an enhanced service to clear leaves and maintain verges working alongside the service provided by BDC.
